Professional, Gold Seal Certified™ (P.GSC) Program

Guidelines for Applicants

The Canadian Construction Association welcomes your interest in becoming a **Professional, Gold Seal Certified (P.GSC)**. This document describes the guidelines you will need to follow in order to qualify for the P.GSC designation.

Eligibility

The designation of Professional, Gold Seal Certified, is open to candidates who:

- a) Have obtained a Gold Seal Certificate; and
- b) Have submitted an application form detailing their professional upgrading activities in the previous calendar year; and
- c) Have paid the applicable fees.

Note that a new application is required each year.

Assessment

1. Applicants must work a minimum of 600 hours per year in the certified management occupation; and
2. Applicants must demonstrate that they have gained a minimum of 20 credits in one or more of the following categories
 - a. formal education (normally construction-related courses with defined learning outcomes and an evaluation process.)
1 credit per 1 hour of formal activity towards a maximum of 20 credits/year in this category
 - b. informal education (such as seminars/conferences, self-directed study, attendance in professional meetings, etc.)
1 credit per 3 hours of informal activity towards a maximum of 10 credits/year in this category
 - c. Community Contribution (such as involvement in community-based or charitable organizations, technical or professional associations, mentoring, etc.)
1 credit per 3 hours of informal activity towards a maximum of 10 credits/year in this category
 - d. Teaching (including giving presentations, seminars and workshops)
1 credit per 3 hours of informal activity towards a maximum of 10 credits/year in this category
 - e. Building the construction industry (contributing to activities that improve the construction industry, such as committee work (*1 credit per 1 hour*), submitting patents (*10 credits per patent registered*), publishing papers in peer-reviewed journals (*5 credits per article*), etc.)

Public Notice

P.GSC-designated individuals will:

- Be listed as P.GSC on the Gold Seal section of the CCA web site;
- Receive a P. GSC certificate on approval of the application;
- Receive a P.GSC hard hat in the first year of designation and an annual P.GSC decal.
- Be authorized to use the letters "P.GSC" as recognition of their ongoing commitment to professional development in construction management.

IMPORTANT NOTES:

- Standards will be monitored annually by the Gold Seal Management Program.
- Gold Seal administrators will audit a percentage of applications to ensure program integrity.
- Annual fee is \$200.00 (+GST or HST where applicable), per certificate.
